2021 NATIONAL SCOUT JAMBOREE QUALIFICATIONS

SCOUTS BSA LEADER QUALIFICATIONS

All Jamboree Scoutmasters, first, second, and third assistant Scoutmasters must meet the following:

- Possess a current BSA membership with a Scouts BSA troop.
- Scoutmasters, 1st assistant, and 2nd assistant scoutmasters must be at least 21 years old by the first day of the Jamboree.
- Applicants must be currently serving in any adult troop leadership position.
- Scoutmaster and Assistant Scoutmaster applicants must have completed Scoutmaster specific training.

For 3rd Assistant Scoutmaster:

- 3rd Assistant Scoutmasters must be at least 18 years of age by the first day of the Jamboree, but not yet 21 years old by the last day of the Jamboree.

VENTURING AND SEA SCOUTING LEADER QUALIFICATIONS

All Venturing Advisors and Sea Scout Skippers must meet the following requirements:

- Have a current BSA membership with a Venturing Crew.
- Be at least 21 years of age by the first day of the Jamboree.
- Complete Venturing or Sea Scouting leader specific training.
- Be actively serving as a Crew advisor/associate advisor or Sea Scout Skipper/Mate
- NOTE: Female leaders are encouraged to apply so we can meet YPT requirements!

All Applicant Qualifications:

- All adult leaders must complete the BSA Youth Protection training within one year of the last day of the Jamboree.
- Must meet the medical and body mass index requirements.
- Have filed personal and health record by April 15, 2021.
- All must be approved by the Local Council. **Turn in applications ASAP**.
- All fees must be paid to the Local Council per their payment schedule.
